Primarily such evidence should be the current and/or previous passport/s. If enquirer is not in the possession of such passport/s other admissible documentation includes:
  - Council tax records
  - tax returns
  - A letter from present/previous employer/s confirming employment history
  - Confirmation of School/College/ University attendance.

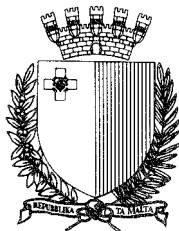
